

## Consent to the processing of personal data

***(pursuant to Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), hereinafter referred to as "GDPR" and also pursuant to Act No. 101/2000 Coll., on the Protection of Personal Data and on Amendment to Some Acts, as amended (jointly referred to as the "Act")***

I hereby grant to **Expobank CZ, a.s.**, ID No. (IČ): 148 93 649, registered office at Vítězná 126/1, Malá Strana, 150 00 Prague 5, registered in the Commercial Register maintained by the Municipal Court in Prague, Section B, Insert 476 (hereinafter referred to as "**the Bank**"), consent to collection, monitoring, profiling, processing, evaluation (manual and automated), and storage of my personal data, primarily name, surname, title, permanent residence/place of business, date of birth, birth registration number, bank account number, data from the submitted identification documents, information on payments and payment discipline, telephone and e-mail, IP address, cookies, under the Bank's Business Terms and Conditions and under Information on Processing of Personal Data (hereinafter referred to as "**Information Memorandum**"), for the purposes of:

- identifying my relevant needs as a client of the Bank;
- offering and providing appropriate business offers and benefit programs of the Bank;
- verification of a customer creditworthiness (verification and evaluation of payment discipline via Unified Register of Debtors).

This consent shall be effective for the duration of the contractual relationship between me and the Bank and, subsequently, 5 years after its termination. I am aware that I may withdraw the abovementioned consent at any time, that the provision of my personal data for the abovementioned purposes is a contractual requirement of the Bank, and I declare that I give my consent freely and voluntarily. I am aware that I may withdraw this consent at any branch of the Bank, by means of Internet Banking, by sending a letter to the Bank or by e-mail at [dpo@expobank.cz](mailto:dpo@expobank.cz). I further declare that I am acquainted with the Information Memorandum, in which my rights are described in detail, I fully understand the Information Memorandum and I am aware that information provided in this Information Memorandum may be updated or changed.

I understand that in connection with entering into a contractual relationship and in terms of the legitimate interest of the Bank, the Bank is authorized to process my personal data for the purposes of direct marketing (information and product campaigns) on the basis of GDPR and the Act. However, I can object to information being collected and stored.

Besides, I give the Bank my consent to sending messages, information, confirmation of message delivery, invoices, appeals, reminders and other announcements regarding the contractual relationship and its fulfillment via SMS or electronic means (in particular by e-mail) if such contact is available. Likewise, my consent applies to sending of commercial announcements in electronic and written form regarding Bank's services and products; I can object to commercial announcements being sent electronically under applicable law.

At the same time, I acknowledge that not granting or withdrawing consent to the processing of my personal data under the preceding paragraphs may result in inability to provide me with services in a personalized manner or in full.
